# Highlights for June 2018



- 
1. There were five (5) bulk trash violation notices issued to residents for heavy trash at the curb.
  2. Code Enforcement removed 39 signs from poles, 20 from right of ways; total signs removed for the year is 374.
  3. There were 35 abandoned vehicles in the residential area, nine (9) in the business area and two (2) in the Apartment areas: four (4) were impounded
  4. For the first six months of 2018 we have had a total of 183 abandoned vehicles in town, 13 of those have been impounded!
  5. Grass violation notices Issued – Nine (9) violations were issued for the month of June
  6. Code Enforcement received Seven (7) Graffiti complaints.
