# Highlights for July/August 2018



1. There were **ten (10)** bulk trash violation notices issued to residents for heavy trash at the curb.
2. Code Enforcement removed **-106** signs from poles, **50** from right of ways; total signs removed for the year is **497**.
3. There were **62** abandoned vehicles in the residential area, **36** in the business area and **10** in the Apartment areas: **nine (9)** were impounded.
4. For the first eight months of 2018 we have had a total of **-299** abandoned vehicles in town, **22** of those have been impounded!
5. Grass violation notices Issued – **24 violations were issued. During the months of July and August**
6. Code Enforcement received **five (5)** Graffiti complaints.
