# Highlights for September 2018



- 
1. There were nine (9) bulk trash violation notices issued to residents for heavy trash at the curb.
  2. Code Enforcement removed -37 signs from poles, 33 from right of ways; total signs removed for the year is 567.
  3. There were 25 abandoned vehicles in the residential area, six (6) in the business area and one (1) in the Apartment areas: two (2) were impounded.
  4. For the first nine months of 2018 we have had a total of -331 abandoned vehicles in town, 24 of those have been impounded!
  5. Grass violation notices Issued – (Ten) 10 violations were issued. During the month of September
  6. Code Enforcement received four (4) Graffiti complaints.
