# Highlights for October 2018



1. There were **six (6)** bulk trash violation notices issued to residents for heavy trash at the curb.
2. Code Enforcement removed **-24** signs from poles, **24** from right of ways; total signs removed Year-to-date is **616**.
3. There were **27** abandoned vehicles in the residential area, **three (3)** in the business area and **eight (8)** in the Apartment areas: **six (6)** were impounded.
4. For the first 10 months of 2018 we have had a total of **-369** abandoned vehicles in town, **30** of those have been impounded!
5. Grass violation notices Issued – **12 violations were issued, during the month of October.**
6. Code Enforcement received **two (2)** Graffiti complaints.
