Highlights for November 2018



1. There were **seven (7)** bulk trash violation notices issued to residents for heavy trash at the curb.
2. Code Enforcement removed **19** signs from poles, **18** from right of ways; total signs removed year-to-date is **653**.
3. There were **24** abandoned vehicles in the residential area, **11** in the business area and **seven (7)** in the Apartment areas: **one (1)** was impounded.
4. For the first 11 months of 2018 we have had a total of **411** abandoned vehicles in town, **31** of those have been impounded!
5. Grass violation notices Issued – Two **(2) violations were issued. During the month of November**
6. Code Enforcement received **two (2)** Graffiti complaints.
