Highlights for June 2019



1. There were **five (5)** bulk trash violation notices issued to residents for heavy trash at the curb.
2. Code Enforcement removed **-29** signs from poles, **16** from right of ways; total signs removed year –to- date is **320**.
3. There were **29** abandoned vehicles in the residential area, **six (6)** in the business area, **15** in the apartment areas and **three (3)** were impounded. Year –to- date we have had **286** abandoned vehicles and **37** have been impounded.
4. There were **seven (7)** grass violation notices issued.
5. Code Enforcement received **eight (8)** Graffiti complaints.

Other Code Enforcement Activities:

- During the Month of June The Code Department has been working with the business to renew their yearly business licenses.
